Therefore Firm 1 i.e. M/s Tahsildar Singh Security Services, Vill Post Rajdhani, Distt Gorakhpur-273202 is become unresponsive for supply of manpower at KV ITI Mankapur.

**Conclusion:**

Since as per KVS account Code there are only two heads in Kendriya Vidyalaya Sangathan for supply of Man Power Services i.e. Security Guards (Without Arms) and Conservancy staff (Sweeper & Mali). Therefore the comparative Statement has been made on the basis of these two accounts. The casual labours are supplied as per requirement, hence it is made separately.

Since the contract may come into force from August 2021, at that time the rate of EPF (13.00% with ceiling 15000) and ESIC (3.25), therefore rate has been calculated on similar ESIC and EPF rate as per latest government circular for all firms.

For security services, it is mandatory for contracting agency must have license from the Home Department, Govt of Uttar Pradesh for running business of private security agency operating in Uttar Pradesh.

It is observed that the Service charges quoted by firm 7 i.e. M/S Samar Security Services, P.O. Bakhara Distt Deoria- 274202 is not feasible in practice and such type of fraction of paisa may not be transacted through bank. It is quoted as 0.01 paisa (as in mathematical editing in zero of rupees it become zero) which is negligible and committee collectively considered as no service charge quoted by firm no.7 i.e. M/S Samar Security Services, P.O. Bakhara Distt Deoria- 274202, hence firm no. n7 will not be considered for supply of manpower service at KV ITI Mankapur.

For security service the rate quoted by firms 3, 4, 5, 6 is same therefore the final work order will be placed only after consideration on the basis of valid minimum rate of all six workers taken together as per our term point (i) of Evaluation of Financial Bid.

As per our terms "quoted price" point (ii), the firms 3,4,7 and 8 have not quoted as per our terms and condition and quoted higher rate of remuneration for sweeper.(Reference S.O.186(E), Schedule Part I category of employee I (unskilled) for area C.

Firms 2 i.e. M/S Royal Security and Manpower services, EE-150, Doorwani Nagar, ADA Colony, Naini Prayagraj, U P - 211008, firm 5 i.e. M/S R R Solutions, E-1176, OMAXE City, Rai Bareli Road, Lucknow and firm 6 i.e. M/s Industrial Security Guard Services, 31/29 Old Mumfordganj, Prayagraj - 211002 have quoted only the valid rate for sweeper as per our terms and conditions.

After evaluation of financial bid under consideration of point (i) of evaluation of financial bid our terms the valid minimum rate of all six workers taken together i.e. 03 security guard, 02 sweepers and 01 mali, the firm 5 i.e. M/S R R Solutions, E-1176, OMAXE City, Rai Bareli Road, Lucknow and Firm 6 i.e. M/s Industrial Security Guard Services, 31/29 Old Mumfordganj, Prayagraj - 211002 have quoted the same minimum rate for supply of manpower in KV ITI Mankapur.

The Committee has thoroughly observed the technical bid for these two firms i.e. firm 5 i.e. M/S R R Solutions, E-1176, OMAXE City, Rai Bareli Road, Lucknow and Firm 6 i.e. M/s Industrial Security Guard Services, 31/29 Old Mumfordganj, Prayagraj - 211002 and found that the working experience of the firm 6 i.e. M/s Industrial Security Guard Services, 31/29 Old Mumfordganj, Prayagraj - 211002 is more in terms of establishment of firm and working in different Kendriya Vidyalyas as well as other organizations (is more) than the firm 5 i.e. M/S R R Solutions, E-1176, OMAXE City, Rai Bareli Road, Lucknow.
